EXECUTIVE OFFICE FOR IMMIGRATION REVIEW

A hardware failure has resulted in the agency's inability to perform some functions related to its computer systems. Immigration courts are still operating on their normal schedule, but some cases may be continued while we continue to work through this issue. The Board of Immigration Appeals is continuing to process cases each day, but is prioritizing its caseload to compensate for reliance on manual processes. As previously stated, applications such as the case information hotline and eRegistration are not operational at this time. We are continuing to evaluate the problem and are hard at work to find a solution.

EOIR primarily decides whether foreign-born individuals, who are charged by the Department of Homeland Security (DHS) with violating immigration law, should be ordered removed from the United States or should be granted relief or protection from removal and be permitted to remain in this country.
