In light of defendants' objections to plaintiffs' proposed notice to the class, plaintiffs propose modifying the paragraph to which defendants' object. Plaintiffs propose that the paragraph read as follows:

Complete Interpretation

In 1992 the Immigration Courts in Los Angeles, San Diego, and El Centro adopted a policy which requires complete interpretation or summarization of everything that is said during your immigration court hearing.

The testimony of all witnesses during your hearing should be interpreted for your benefit. This applies whether you have an attorney or whether you are representing yourself.

If you are <u>not</u> represented by an attorney during your hearing then any discussions between the judge and the INS attorney must be interpreted. The judge's decision must be interpreted. Any discussion of legal, procedural, or other administrative matters must either be interpreted or summarized for your benefit.

If you <u>are</u> represented by an attorney during your hearing then any legal arguments or objections by your attorney or by the INS attorney must be interpreted.

The judge's decision must be interpreted. Discussions between the judge and your attorney or the INS attorney must either be interpreted or summarized for your benefit.
