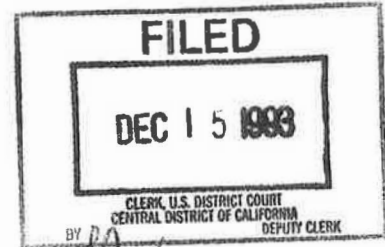



9 Immigration Courts.


10 Plaintiffs shall notice a hearing immediately subsequent
